### **ORDER:**

In the Government Order first read above, administrative sanction was accorded for the implementation of Tamil Nadu Urban Healthcare Project at a cost of Rs.1633,69,50,000/- with the assistance of Japanese International Co- operation Agency (JICA). The Project Director Tamil Nadu Urban Healthcare Project was permitted to establish Tamil Nadu Urban Health Care Society to implement the project in 21 Urban Towns / Cities in 17 Districts of Tamil Nadu. In Government Order second read above, sanction was accorded for the creation of Project Management Unit for Tamil Nadu Urban Healthcare Project.

2. In the letter third read above, the Project Director, Tamil Nadu Urban Health Project has stated that the following proposal was placed before the State Empowered Committee.

- i. To approve the selection of sole responsive consultant M/s Mukesh and Associates and JV partners to carry out the consultancy services CS-1 as ordered in the G.O. (Ms) No.51, Health and Family Welfare (EAP II-1) Department dated: 22.02.2017 at the approved cost of consultancy INR 33,88,47,192 crores and Non Competitive Components at a cost of INR 14,25,91,463 crores.
- ii. To permit the Project Director, Tamil Nadu Urban Healthcare Project to sign the contract agreement with the responsive consultant M/s Mukesh and Associates and JV partners M/s EHI International (P) Ltd., and M/s Nippon Koei India Pvt Ltd., as proposed in the para 4 and at a cost as proposed above.
- iii. The Project Director, Tamil Nadu Urban Healthcare Project may be permitted to make payments as per the terms of the approved contract agreement.

- iv. The Project Director, Tamil Nadu Urban Healthcare Project may be permitted to make an advance payment of 10% of the total amount of contract on submission of inception report and bank guarantee at the time of inception and to make periodic payments as per contract agreement.

3. The State Empowered Committee has approved the above proposal and directed the Project Director, Tamil Nadu Urban Healthcare Project to get the proposal approved by the Government as the cost is more than the financial powers of the Committee.

4. The Project Director, Tamil Nadu Urban Healthcare Project has requested orders in this regard.

5. The Government after careful consideration decided to accept the proposal of the Project Director, Tamil Nadu Urban Healthcare Project and ordered as follows:-

- i. The selection of sole responsive consultant M/s Mukesh and Associates and JV partners to carry out the consultancy services CS-1 as ordered in the G.O. (Ms) No.51, Health and Family Welfare (EAP II-1) Department dated: 22.02.2017 at the approved cost of consultancy INR 33,88,47,192 crore and Non Competitive Components at a cost of INR 14,25,91,463 crore is approved.
- ii. The Project Director, Tamil Nadu Urban Healthcare Project is permitted to sign the contract agreement with the responsive consultant M/s Mukesh and Associates and JV partners M/s EHI International (P) Ltd., and M/s Nippon Koei India Pvt Ltd., at the cost approved above.
- iii. The Project Director, Tamil Nadu Urban Healthcare Project is permitted to make payments as per the terms of the approved contract agreement.
- iv. The Project Director, Tamil Nadu Urban Healthcare Project is permitted to make an advance payment of 10% of the total amount of contract on submission of inception report and bank guarantee at the time of inception and to make periodic payments as per contract agreement.
